The incident in which Mr. Durbin refers to took place on 12/7/19 vs. Prairie Central.....

- I was asked to come to the coaches office about 20 min after the game by an asst. coach and he said the officials needed me.
- As I entered the room, Official Mike Mercer was screaming at our coaches, then started screaming at me. I asked him to calm down and tell me what was wrong.
- Mike told me that the Prairie Central Coach entered their locker room and demanded their numbers (official ID #). They told him to leave several times and he wouldn't leave. Mike then raised his voice at me, blaming me for not protecting them.
- was going to the IHSA. I reminded him that the P.C. Coach was responsible for his own behavior. The P.C. Coach entered the Coaching Office through the back door - I notified him that we had security outside in the hallway as we do for all of our games. I apologized several times but he continued to berate me and tell me how he and circumvented the security officer. Mike continued to yell, so I told him it was time to leave and I would be speaking to Don King, the Officials Assignor.
- After talking with Don and him talking with Mike, we decided it was best that Mike not officiate any games at Morton for the remainder of the year. I agreed to let Mike officiate away games. Don said Mike agreed with that and he was on for 3 or 4 games throughout the rest of the year. We did receive a letter from the IHSA about the incident, but there was no "hand slapping" or other punishment/consequence handed down to us.
- directions. That was the first and only incident we have had over the last 6 years regarding a coach confronting an official. We take good care of our officials and - I did talk with Officer Ehlke (our SRO) after the incident and asked that our security guard stand closer to the officials room and watch for anyone from both always look out for their safety.

By this time I missed the umpires and then turned around again to Mr. Durbin complaining to me. I said once again to stop or my next conversation would be with the administration and board. He told me 2 times that "I'd better not do that" while pointing his finger at me. I told him not to threaten me and to go home. He then offered to apologize to me. I told him I did not want his apology and to just go home. He got angrier with that response and went back to yelling at me. There was a large crowd of parents around at this point. Mr. Durbin finally left to talk with some other people and I walked away to my car. I had several parents and 2 staff members approach me to check on me to make sure I was ok. I went home and notified Mrs. Ripka and the admin team of a run in with Mr. Durbin.
