Superintendent's Report -

- > Dr. Hill reported on end-of-year events:
 - MHS diploma distribution took place at the high school as planned on Sunday, May 17. Graduates came at assigned times and families had the opportunity for photos of graduates on stage. Dr. Hill enjoyed the opportunity to visit with many of the students. He noted the event was very well planned and organized.
 - A virtual awards ceremony will be available to staff for viewing at 9:00 a.m. Thursday, May 21. This is an annual event that takes place on the last day for teachers at the Bertha Frank Performing Arts Center. Employee service awards will be announced along with retiree recognition. Retirees include Teachers Barb Blanco, Therese Scifres, and Nadine Worstell. Educational Support Staff Jill Parod, Terri Schuck, and Carol Williams. The highlight will be the announcement of the Master Potter, Potter's Hand, and Dana Ashby awards.
- > Dr. Hill and Dr. Cross participated in a meeting with local superintendents to discuss options for opening school in the fall. Another meeting is scheduled for the first week of June.
- > Dr. Hill noted two grant opportunities for the district -
 - Fast Track Public Infrastructure Program IL Dept. of Commerce & Economic Opportunity
 - Elementary and Secondary School Emergency Relief Grant ESSER Grant Federal funds based on Title I Part A funds in 2019

Administrators are following personnel needs closely as to what positions will be needed in the fall depending on the school environment.

President's Report -

Dr. Beaty allotted time for Board members to discuss pros and cons of opening school in the fall. Discussion included ramifications of opening against the executive order; remote elearning – teachers did the best they could this spring, but nothing can replace in-person teaching; if in-person teaching would begin in the fall, remote e-learning may become a part of the school year during breakouts. School districts need to work for local control for individual districts to make their own decisions as to what is best for them.
