Minutes of the Committee of the Whole Meeting of the Board of Education of Morton Unit School District 709 held September 30, 2014, at the Morton Education and Administration Center.

The Committee of the Whole meeting was called for the purpose of the Board of Education to have a more in depth discussion on the topic of facilities.

Dr. Hall opened the meeting with a presentation reviewing the capacity/utilization study, needs of each building, possible solutions for needs; work of the Facilities Advisory Committee (FAC), recommended options that emerged from the FAC, costs, other facilities work that District 709 is doing, and a timeline. This presentation is available on the District website.

Following Dr. Hall's presentation, Board members discussed:

- Suggested questions to ask community members that attend the 709Connect:Facilities meetings which included:
 - \triangleright Opinions of 5 8 grade model?
 - ➤ Would they like to see a lesser plan additional gyms/additional space for kindergarten classrooms?
- Building utilization percentage over time: how would various options keep us at the desired utilization?
- New middle school option vs. new high school option need to look 10 or more years into the future lesser time is too short.
- Need to continue with the 5-year facilities plan to keep up with immediate needs and regularly scheduled maintenance in all of the buildings.
- Timeline and costs out 20 years would like to get more accurate costs for various plans new construction and remodeling of current buildings.
- Middle school option whether at high school or a newly constructed building what grades would be included? Possibly start with 6 8 grade first and add 5th grade later. Would not want to see a 7-period day for 5th and 6th graders, but with 2-3 teachers co-teaching a grade.
