Stella Nau, Secretary of the MHS Student Council reported on recent and upcoming activities including Santa calls to children this past Christmas, a blood drive planned for February 11, and St. Jude week scheduled for March 21 - 24.

### Game Ball Run Update -

Dr. Smock read the mission of Game Ball Run -

A community event to raise money and awareness for Children's Hospital of Illinois -

- Involve all schools and all students and our community
- An opportunity for our boys' basketball team to serve in a philanthropic role
- The chance to give back to an organization that has served multiple families and students in the Morton schools.

The run was held on Thursday, January 28, for the first time at the new track at MHS with about 50 participants as well as the boys' basketball team and coaches. Friday, January 29, a ceremony was held prior to the varsity contest where sponsors, runners and Miracle families were recognized. The total amount raised this year was announced - \$62,180.49 - \$28,000 of that total was raised in District 709 schools through coin wars, dodgeball at MJHS, staff paying to wear jeans to work and Hoops for the Hospital. The four year total donated to Children's Hospital is nearly \$162,000.

#### President's Report -

President Bernier reviewed a list of upcoming opportunities to share facts about the referendum. She noted that board members are available to speak to any group and to let her or Dr. Hall know of any that would welcome them. There are Town Hall meetings scheduled on February 9<sup>th</sup> at 6:30 p.m. at Grundy School and February 29<sup>th</sup> at 6:30 p.m. at Lincoln School.
